Foster Parent Support Services

Below are responses to questions submitted at the Solicitation Call or via email, grouped by Name/Agency:

Name/Agency	Question	Answer provided
ОНИ	Is there a budget range?	No. We wanted people to be creative and think out of the box, including how in kind supports could be utilized to offset costs. We deliberately did not include a range for this reason. We will be looking at each proposal and budget to see how that lines up with building a support network.
OHU	Will there be any startup funds?	No.
ОНИ	Is HFC aware of any space available within the community?	There are many strong partnerships in the community (i.e., faith-based, schools and businesses) and we would encourage you to look at how you may be able to leverage some of those relationships.
ОНИ	Will there be any leeway on hiring staff due to the short timeframe between award notification and start date?	There will be some flexibility in the hiring timeline. The goal is to get support groups established in the community.
OHU	Will any equipment be available for staff?	HFC and the IT department will work with the selected applicant if there is a need for technology equipment specifically outlined in the proposal.
ОНИ	Could we have more specifics as to the requirements of the proposal? Number of pages, font, etc.?	HFC realizes that there may be applicants submitting proposals for the first time; therefore, we wanted to allow flexibility. Please submit what you think is appropriate for this request.

ОНИ	Do you currently hold Foster Parent support groups and how often do they meet?	The TLC Association has been meeting locally in Polk County for many years. Their last meeting at First Baptist Church in Bartow was in March 2015. At this time HFC is not aware of their future meeting location. The TLC Association is open to foster parents, relatives, non-relatives, and adoptive families. There is also the Heart2Heart support group located in Haines City.
ОНИ	Is there a current Foster Parent support agency providing this service?	The TLC Association has provided support for foster parents, relatives, non-relatives, and adoptive families. However, there are currently no support groups specifically for currently licensed foster homes in Circuit 10.
ОНИ	What are your expectations for data collection methodology for evaluation and evidenced based curriculum?	As you research curriculums you will find that there are a variety of effective models. However, we have not identified a particular one that we expect you to use. Data collection would be a valuable piece of a proposal. HFC will provide some basic expectations.
ОНИ	Will this team be required to give foster parents their training hours for re-licensing?	That is not the ultimate goal of this proposal. We feel that we already offer a strong array of training opportunities. The goal is having the families come together for support.
ОНИ	Will there be other expectations outside of just running the group?	HFC will have a point of contact that will serve as a liaison to ensure that information is communicated between the support group and HFC.
ОНИ	Is there a current Community Resource book?	There is no book; however, the Aunt Bertha website would be an excellent resource for families and the Foster Parent support network.

ОНИ	What is the current curriculum that is taught to prospective foster parents?	Passport to Parenting. It has many components tied to trauma and Emotional Regulatory Healing (ERH). The curriculum also helps to prepare families for the placement of children in their homes.
ОНИ	Would we be able to have access to the Foster Parent training curriculum so that we may become familiar with the philosophy?	Yes.
ОНИ	How do we get a copy of the curriculum?	Contact the Procurement Manager, Kim Corpus. The curriculum can be picked up or mailed to you.
ОНИ	What times and dates are groups currently being held?	The TLC Association meets Mondays once a month in Bartow and Heart2Heart meets Fridays once a month in the Ridge area. TLC will be moving to Lake Wales, per Cindy Strickland.
ОНИ	How many new homes are licensed each year and what is our goal?	Our ultimate goal is to have 250 licensed homes in our network. We have a monthly goal of 5 new homes each month. 63 were licensed last year. Working towards a net gain of 25 homes a year.
ОНИ	Will this be a one-year grant?	Yes, the initial contract will run from June 2015 to June 2016. HFC is committed to supporting the development of quality foster parent support services. If positive outcomes are achieved HFC will consider renewing the contract.
Covenant	Would the support group be a resource to families who may be experiencing disruptive behavior of a child in the home?	The support group in the community could be a resource for local foster parents to gain support, guidance, and ideas for additional resources.

Covenant	Would the group help in transportation of kids?	Some natural supports between families may develop but the focus of the group is to facilitate a model of support for foster parents.
Covenant	How would this differ from the foster parent association?	There is a statewide foster and adoptive association. The TLC Association and Heart2Heart are local support groups. We do not know the future meeting location of the TLC Association. However, the TLC Association and Heart2Heart are options for foster families to attend if they choose. We are looking to expand and build a broader foster parent support group network.
Covenant	Will this replace TLC or Heart2Heart?	That is not our intent.
Covenant	Would one outcome be looking at the number of families participating in a support group?	Yes. The TLC Association had 88 paid families that joined last year, which includes adoptive families. The TLC Association also provides services for relative and non-relative families. We estimate about 25-30% of our current foster home network attend. This RFP is intended specifically for building support groups for local foster parents. There are separate contracts in place for relative, non-relative, and adoptive support group facilitation within our community.
Key Assets	Do you have a set amount of deliverables you want reported on?	HFC will ask for a monthly stat report but we have not yet identified what specifically will be reported. This will be discussed internally and provided at a later date.
Devereux	In an effort to help identify locations that are convenient to the caregivers do you have a map that shows where foster homes are located?	We have tracked homes by zip codes, and we can produce a list of where the homes are located.

Devereux	There are specialties within foster care groups such as STFC, Medical, Delta, etc. Will this support group encompass all the different types of foster parents or only focus on general foster parents?	We are looking at general support group facilitation.
Devereux	Do you have an age breakdown of children who would potentially need child care – based on your experience with TLC? For example: #/% infants, < 5 years and school age?	The local TLC Association has been open to adoptive, foster, relatives and non-relatives. The mix of age groups of children the church provided child care for that Heartland for Children paid for each month fluctuated over the years. The President of the local TLC Association took the RSVP numbers from caregivers for the number of children each month that needed child care and turned those numbers in prior to their meetings. HFC did not keep a log of the number of children per age group the church served each month. The church did staff each room based upon the child to staff ratios required by child care licensing. Child care was offered for infants through school age. There was a separate teen program that TLC organized.
Devereux	Will the provider be able to limit participation per group if we develop the capacity to meet the demand as it increases?	The provider will need to determine group capacity that a group facilitator will be able to provide quality support group facilitation to during the scheduled support group session in a specific location.
Mentor	Has HFC ever surveyed foster parent wants and needs?	Yes, we annually survey the foster parents and we can make that available upon request to the Procurement Manager.
Cyndy Strickland	How will the map be made available?	We will try to post it with the responses on Friday, April 10.
Cyndy Strickland	Are we interested in having multiple groups across the circuit targeting attendance of our foster parents?	We are looking for quality groups, quantity is to be determined based on the proposals. We are looking for quality groups with strong facilitation.

Cyndy Strickland	Please explain HFC's philosophies of partnership, transparency, and trauma integration (page 3, item number 2 of RFP).	HFC values working in partnership which includes open, transparent communication and an emphasis on problem solving. We are striving to develop a trauma integrated system of care. This philosophy includes shifting the perspective from "What is wrong with you?" to "What happened to you?" It also places a focus on helping individuals to heal from past traumatic events.
Cyndy Strickland	Please elaborate on (page 3, item number 3 of RFP): Describe an understanding of the impact of trauma on parents' behavior and coping strategies, as well as, the behavioral manifestation of toxic stress on children's behavior.	Whoever is facilitating the support group should be able to articulate how trauma and toxic stress affects behavior of both children and adults.
Cyndy Strickland	Would it be a conflict to apply on behalf of an organization and also personally?	No.
Cyndy Strickland	Under who facilitates, may we simply state an organization name or should the proposal break down each individual facilitator.	Need to identify facilitators including their experience and their skills and abilities to lead groups of caregivers.

Foster Parent Support Services

Heartland for Children recognizes the need for quality foster parent support group facilitation in Circuit 10. Heartland for Children (HFC) is seeking one (1) or more individuals or organizations that are qualified and interested in facilitating Foster Parent Support Groups in Polk, Highlands and Hardee Counties (Circuit 10). This RFP is open to all eligible organizations and individuals in Florida that meet the qualification requirements specified in this procurement announcement.

The date and time of the first official posting of this RFP is March 19, 2015 at 1:00PM local time in Bartow, Florida.

Submission Deadline: April 30, 2015

Anticipated Grant Start Date: June 15, 2015

Anticipated Number of Awards: One (1) or more

Anticipated total funding available for award through this RFP is to be determined. Multiple recipients may be selected.

Payment methodology: Fixed monthly payments.

Actual payment for services will be contingent on HFC's receipt of funding from the State of Florida Department of Children and Families.

Current data related to the advertised service(s):

• HFC currently has 178 licensed foster homes in Circuit 10 (Polk = 154, Hardee = 5, and Highlands = 19)

HFC will begin accepting responses immediately and no responses will be accepted after 4:00PM local time in Bartow, Florida on April 30, 2015. All responses must be in writing.





General description of the nature of the services being sought:

Foster Parent Support Services

Heartland for Children recognizes that our network of quality foster parents need the opportunity to share information, experiences, and offer support to one another. The need for support is critical, and parents regularly turn to parent groups to find this support. Parent support groups are an effective means of providing information and on-going support to families.

This procurement along with all questions, answers, notices, and modifications will be posted at www.heartlandforchildren.org.

In order to respond to this RFP, interested applicants must:

- Submit a detailed proposal of how you will support foster parents in Circuit 10 including, but not limited to, frequency of foster parent support sessions, methods of communicating with foster parents, support of the children in their care during foster parent support sessions, locations of foster parent support sessions, methods for marketing to and engaging foster parents, etc.
- This proposal is open to various options of providing support, including, but not limited to, use of technology, face to face, other media, or any other means that provides a viable support network.
- Complete and submit the Network Provider Application (Exhibit A) and associated documents/information.

Respondents should consider the large geographical area of Circuit 10. Proposals need not provide for support for the entire circuit. Proposals that intend to provide support to specific areas of Circuit 10 will also be considered.

The completed application and all applicable documents must be submitted to the Procurement Manager and received at the address below by 4:00 PM local time in Bartow, Florida on April 30, 2015. Documents may be hand delivered or submitted to the





Procurement Manager via email at the email address below. It is the responsibility of the applicant to verify HFC's receipt of their proposal. If hand delivered, the applicant must obtain a signed receipt from the receiving HFC staff person indicating the date and time of delivery and who received the application for HFC. All submitted applications should be clearly marked **on the outside of the packaging or in the email subject line** with the following:

Each proposal should provide sufficient information and detail to:

- 1. Describe the support services to be rendered and describe in detail how the meetings will meet the support needs of foster families in Polk, Highlands and Hardee Counties.
- 2. Describe processes that will be established to ensure consistent and open lines of communication and to ensure alignment with HFC's philosophies of partnership, transparency, and trauma integration.
- 3. Describe an understanding of the impact of trauma on parents' behavior and coping strategies, as well as, the behavioral manifestation of toxic stress on children's behavior.
- 4. Describe the experience and backgrounds of the individual or individuals who will be facilitating the support group(s), where the facilitation will occur, and the method of facilitation.
- 5. Describe how you will recruit foster parents from the local communities to engage in and participate in the proposed support groups.
- 6. Detail a line item budget to support the proposal including, but not limited to, venue rental, child care expenses, travel, supplies, etc.

Each applicant will be evaluated on the above noted criteria.
