### REMEMBERING SAFE SLEEP IS AS EASY AS ABCD!



#### **ALONE**

Babies should always sleep alone in their own safe sleep environment such as a crib. There should be no blankets, pillows, toys or bumpers inside the crib.



#### **BACK**

Always place Babies on their Back for nap time and night time sleep. It is the safest position for baby to sleep.



#### **CRIB**

Babies should be placed in a crib, portable play yard or bassinet with a firm mattress and fitted sheet.



#### **DEVELOP A SAFE SLEEP PLAN**

Develop a Safe Sleep Plan that describes where your baby will sleep, coping strategies to use when baby is fussy and who you can call for added support when you need help.
